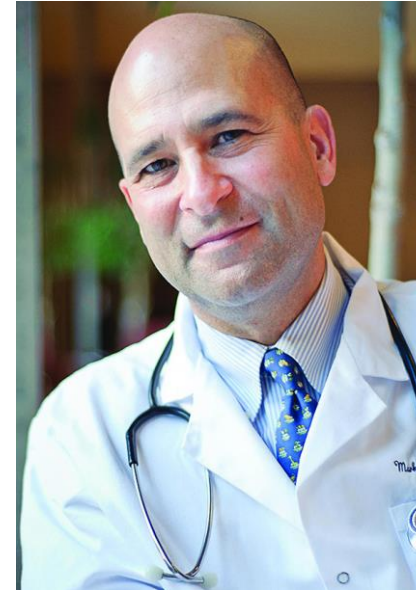
Elder Justice Initiative
